Seniority in service amongst drivers trained to drive AC Low Floor buses is the criteria to be followed. I have already held so by judgment dated 3.7.2015 in W.P.(C) No.20059/2015. The above principle shall be followed in allotting duty to the trained drivers to drive AC Low Floor buses.
