J U D G M E N T

The petitioner seeks promotion as Assistant Transport Officer with retrospective effect from the date on which his immediate junior was promoted. The petitioner points out that Ext.P2 decision of the Departmental Promotion Committee not to grant promotion for want of declaration of probation is bad.
