JUDGMENT

The petitioners have filed Ext.P4 representation objecting to Ext.P2 Government Order in relation to fixation of alignment and the special compensation package. The dispute relates to the drawing of 400 KV High Tension line from Edamon to East Kochi. The petitioners confine their relief to an early consideration of Ext. P4 representation in the circumstances.
