J U D G M E N T

The petitioner is before this Court contending that the petitioner had unwittingly submitted a resignation letter and he had withdrawn it immediately thereafter. The petitioner also submits that he had filed a representation before the D.E.O. to consider his prayer for withdrawal of the resignation, which was replied by Ext.P8. By Ext.P8 it has been informed to the petitioner that no such application is pending before D.E.O.

2. In any event, since the petitioner himself admits that he has withdrawn the resignation, it is not for the Educational Officer or this Court to look into the matter or direct the Manager to consider the same. It will be open for the petitioner to urge the same before the Manager.

The writ petition is dismissed.
