J U D G M E N T

2. Petitioner submits that the election in the School Youth Festival was not fair and she was denied 1st prize. She relies on various credentials to show that she was good performer in *Kuchipudi* dance.

3. The learned counsel for the 1st respondent opposed the prayers of the petitioner.

4. Taking note of the past performances of the petitioner, the petitioner ought to have been given a choice to take part in the District Level CBSE Kalotsavam. Accordingly, the 1st respondent is directed to include the petitioner among the selected candidates in the event *Kuchipudi* dance in District Level CBSE Kalotsavam.
