J U D G M E N T

Petitioners approached this Court on account of delay in issuing sketch to the property comprised in Sy.No.51-A/1 of Kottopadam Village III in Mannarkkad Taluk. It is submitted that the survey was conducted by the Taluk Surveyor and forwarded the same to the Tahsildar as per Ext.P1. It appears that on account of want of file, the Tahsildar was unable to issue the sketch.

2. This Court is of the view that the Tahsildar shall find out the file relating to the matter and if it is not possible, to conduct a fresh survey and issue a sketch to the petitioners. Needful shall be done within a period of three months from the date of receipt of a copy of this judgment.
