J U D G M E N T

The petitioners are aggrieved with the non-consideration of Exts.P7 to P9 revisions filed before the 1st respondent. The revisions are filed on 20.08.2015.

2. In such circumstance, the 1st respondent definitely will have to look at the revisions filed before it and consider the same in accordance with law, after affording an opportunity of hearing, at any rate within a period of four months from the date of hearing. The issue agitated being identical and respondents could be heard together after hearing the authorised respondent of the petitioners or one of them. It is made clear that this Court has not made any observations on merits, which the 1st respondent will consider, in accordance with law.
