J U D G M E N T

The petitioner is aggrieved with the non-consideration of Ext.P8 revision filed before the 1st respondent. The revision is filed on 01.10.2015.

2. I have heard the learned Standing Counsel, Sri. V.M Kurian, appearing for the 7th respondent and the learned Government Pleader.

In such circumstance, the 1st respondent definitely will have to look at the revision filed before it and consider the same in accordance with law, after affording an opportunity of hearing, at any rate within a period of three months from the date of hearing.
