2. It is submitted by the learned Senior Government Pleader that out of 49 seats earmarked for Latin Catholic (LA) all the allotments have been made. It is submitted that except one, all of them have joined. The allotment of non-joining candidate was in the Private Self Financing College and on account of non-joining, the seat was reverted back to the Management.

In that view of the matter, this Court cannot grant any relief to the writ petitioner as he is an aspirant for the quota earmarked LA. Nothing further survives in this writ petition. Accordingly, this writ petition is closed.
