J U D G M E N T

Ashok Bhushan, C.J.

Heard the learned counsel for the petitioner and the learned Government Pleader. No notice is being issued to the 6th respondent in view of the judgment which is being passed.

2. Petitioner claims to be the owner of three stage carriages operating on the route Guruvayur-Pattambi-Palakkad. Petitioner in the writ petition has stated that there has been certain obstruction by crew of other carriages. It is submitted that detailed complaints had been submitted to the Sub Inspector of Police regarding obstruction created by crew of other services, but no action has been taken by the police authorities.

3. Learned Government Pleader submits that Exts.P4 to P8 are only general complaints without giving any specific details on which police could not enquire and take appropriate action. In the facts of the present case, ends of justice deserve in giving

liberty to the petitioner to file appropriate detail complaints before the Sub Inspector, who may look into the same and take such measures as required by law.

With the above observations, the writ petition is closed.
