JUDGMENT

The petitioner approached this Court on account of delay in releasing an amount of Rs.1,57,800/- collected by sale of paddy confiscated from the petitioner.

2. As per Ext.P1 judgment of the District Court, Palakkad in C.M.A. No.44/2010, the confiscation has been set aside.

3. In view of the above, the petitioner is entitled for the release of the value of paddy confiscated from him.

4. It is to be noted that the judgment was rendered on 24/06/2014.

5. In that view of the matter, the amount shall be released to the petitioner within a period of two months

from the date of receipt of a copy of this judgment, unless any order is passed by the competent court interdicting or reviewing the directions in Ext.P1.
