JUDGMENT

The award in the arbitration cases filed by the first respondent Society has become final. The award is put into execution against the petitioners. The petitioners seek easy instalments to repay the award amount and to defer the execution proceedings in the meanwhile.

2. I permit the petitioners to remit the amount covered by the award in the arbitration cases. The amount shall be paid in six equal monthly instalments starting from 15.02.2015. The execution proceedings (EP No. 184/2011) shall be put on hold if the petitioners comply with the conditions in time. The coercive steps can surge ahead if the petitioners commit default in the payment of instalments as directed.

The Writ Petition is disposed of.
