JUDGMENT

All that the petitioners pray is for easy instalments to pay the loan amount and defer the execution proceedings in the meanwhile. It is pointed out that the third petitioner is the sole breadwinner of the family.

2. I permit the petitioners to pay the amount due in six equal monthly instalments starting from 02.02.2015. The coercive steps pursuant to Exts. P2 and P3 notices shall be put on hold if the conditions are complied with. The coercive steps can surge ahead if any one of the instalments are defaulted.
