Petitioner has approached this Court seeking police protection alleging threat from respondents 5 to 8.

2. An interim order has already been passed by this Court on 28.11.2014 by which the petitioner was permitted to file complaint if there is any untoward incident and there was a direction to give protection from the miscreants.
