JUDGMENT

Petitioner is presently working as Sweeper in Sree Vadakumnathan Temple under the Cochin Devaswom Board. Petitioner submits that she is entitled for promotion to the next higher post of clerical cadre. However, without considering petitioner for promotion, tentative steps are being taken to appoint persons directly to the post as per Ext.P4. Petitioner submits that as per the existing regulations, present feeder categories are also entitled for promotion to the higher post. It seems that petitioner has approached the authorities in the year 2010 and 2011.

2. In the facts and circumstances, I am of the view that petitioner shall make fresh request before the second respondent within a period of two weeks from the date of receipt of a copy of this judgment. Thereupon, the second respondent shall take appropriate decision in the matter within a further period of two months.

The Writ Petition is disposed of.
