JUDGMENT

The petitioner seeks easy instalments to pay the amounts due to the respondents and to defer the proceedings for sale in the meanwhile. The sale of the property is scheduled on 29.10.2015 by Exts.P2 and P3 notices shall be adjourned. This is subject to the condition that the petitioner pays a sum of ₹60,000/- towards dues on or before 28.10.2015.
