J U D G M E N T

The petitioner has approached this Court apprehending travel ban. The petitioner is the holder of a passport bearing No.8794434 which was issued by the Regional Passport Officer, Malappuram. The petitioner submits that the travel ban is imposed against him.

2. A statement has been filed on behalf of the respondents. In para.3 it is stated as follows:

“3. It is submitted that the Look Out Circular against the petitioner, which was originated by the Embassy of India, Muscat is seen withdrawn on verification and does not exist in the system at present.”

3. In view of the above statement, this Court is of the view that there is no impediment for the petitioner to travel abroad in accordance with law.
