The writ petitioner herein seeks a writ of mandamus, or other direction for action on her Ext.P1 complaint. Now there is a report from the Sub Inspector of Police, Nedumangadu that the police has already registered a crime on Ext.P1 complaint under Section 66(E) of the Information Technology Act, and that investigation is in progress. The petitioner's grievance stands redressed. What she wants is registration of a crime on her complaint, and investigation. That is now being done by the police, as reported.
