The petitioner seeks a breathing time to file an appeal against Ext. P9 order. It is reported that the appellate authority is shortly to commence sitting at Bangalore. Proceedings under Sections 7Q and 14B of the Employees' Provident Fund and Miscellaneous Provisions Act, 1952 have also followed.
