J U D G M E N T

On 3.12.2014 this Court observed that the matter requires to be heard whether order for investigation as sought by the petitioner can be made now when the police has already submitted final report in the crime, and that the petitioner will have to think of the remedy available to him under the Code of Criminal Procedure for further investigation or otherwise.
