The petitioners, who were Municipality contingent workers, seek disbursement of their retirement benefits, commutation of pension and D.A. arrears.

2. The learned Standing Counsel appearing for the Municipality submits that the payment is not made only due to the financial stringency of the Municipality.

3. In any event, the retired employees have to survive and in such circumstance, the Municipality shall pay 50% of the amounts due within three months and the balance 50% shall be paid within three months thereafter.
