The petitioner is the Manager of an aided school. According to the petitioner, three additional divisions in Standard II, III and IV were to be sanctioned during the year 2007-2008. However, on account of a ban imposed by the Government, posts were not sanctioned. Petitioner submits that on account of the lifting of the ban, the posts are to be sanctioned.
