J U D G M E N T

The petitioner was granted transit permit as per Ext.P2 to remove ordinary earth from the site covered by building permit. The petitioner submits that he could not remove the entire quantity within the time granted as per Ext.P2. The petitioner approached the Geologist by Ext.P4 for extension.

2. Considering the facts and circumstances this Court is of the view that the one months time can be granted after verifying the quantity to be removed from the site. The Geologist shall issue necessary orders in this regard. The one month period would be reckoned from the date on which transit permit is granted.

The writ petition is disposed of, as above.
