JUDGMENT

The petitioners confine their relief for easy installments to pay the amount demanded under Ext.P6 proceedings to the Employees Provident Fund Organization. I am inclined to grant a breathing time to the petitioners taking note of the precarious financial condition of the hospital and the research centre.

2. I permit the petitioners to pay the amount due in 12 equal monthly installments with applicable interest starting from 30.11.2015. The coercive steps pursuant to Ext.P6 order shall be put on hold if the petitioners comply the conditions.

3 The coercive steps can be continued if the petitioners commit any default in payment of any one of the installment.

The writ petition is disposed of.
