This writ petition is filed alleging harassment by the police. Learned Government Pleader submits that an enquiry is proceeding against the petitioner in connection with a crime in which a girl is missing. Twice information given by the petitioner was found to be false and every time when he is summoned, appropriate notice had been issued by the police.

2. Issuance of notice for investigation purposes does not amount to any harassment. It is submitted by the learned counsel for the petitioner that, petitioner apprehends third degree methods to be adopted. If at all, there is any such action, it shall always be open for the petitioner to take appropriate proceedings in accordance with law.
