JUDGMENT

The petitioners are husband and wife, who challenge Exhibit P2 order of the Appellate Tribunal under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 [for brevity "the Act"]. The provisions of the Act were invoked by the respondents 4 and 5, seeking maintenance from the 1st petitioner, the son of the respondents 4 and 5. The learned counsel for the petitioners only seek for instalments to pay the amounts directed in Exhibit P2.
