J U D G M E N T

The writ petition was filed by the petitioner bank seeking a direction to the Chief Judicial Magistrate, Ernakulam, to pass orders on Ext.P1 application of the petitioner, to provide police assistance for taking possession of the secured assets scheduled to Ext.P1 application. The grievance of the petitioner in the writ petition was primarily against the delay in the consideration of the matter by the Chief Judicial Magistrate. When the matter taken up for orders on 08.01.2015, I called for a report from the Chief Judicial Magistrate, Ernakulam, as to the status of the petitions posted before him. By a report dated 14.01.2015, the Chief Judicial Magistrate informed this Court that orders were ready in the matter and would be pronounced on 23.01.2015. It is now learnt that the Chief Judicial Magistrate has since passed orders on 23.01.2015 itself. Taking note of this development, I close this writ petition as infructuous.
