This writ petition has been filed by the petitioner seeking police protection alleging threat from respondents 3 and 4 and obstruction in the matter relating to conduct of a unit by the petitioner. An interim order had already been passed by this Court on 15/12/2014.

2. It is submitted by the learned Government Pleader that during the pendency of the writ petition, no untoward incident had been reported. Learned counsel for respondents 3 and 4 would further submit that directions had already been issued by this Court as per Ext.P2 interim order dated 24/11/2014 in WP(C) No.31302/2014 directing the Municipality as well as the Pollution Control Board to conduct periodical inspection in the premises of the petitioner.
