JUDGMENT

The petitioner approached the District Collector by Ext.P5 under Clause 6 of the Kerala Land Utilization Order, 1967(for short, the 'KLUO').

This Court is of the view that Ext.P5 shall be considered by the District Collector after calling for a report from the Agricultural Officer regarding the status of the land. If it is not included as paddy, nilam or wetland in the draft data bank, appropriate decision shall be taken under Clause 6 of the KLUO. The decision shall be taken on Ext.P5 within a period of two months after issuing notice to the petitioner.

The writ petition is disposed of as above.
