JUDGMENT

Shaffique, J.

This writ petition has been filed seeking police protection in the matter relating to loading and unloading work to be carried on by the petitioner with his own registered employees.

2. An interim order had already been passed by this Court observing that the petitioner has his own permanent workers with identity cards as per Rule 26(A) of the Headload Workers Rules. In such event respondents 1 and 2 have no right to demand loading and unloading work in the petitioner's premises.

With the above observation the Writ Petition is disposed of.
