JUDGMENT

The petitioner has approached this Court on account of non-acceptance of basic tax from him in respect of the property comprised in Survey No.40/6 of Chinnakanal Village. The petitioner refers title as LA 218/93 issued by the Special Tahsildar, Ernakulam. The petitioner made representation as per Ext.P4 before the Tahsildar.

This Court is of the view that appropriate decision shall be taken on Ext.P4 by the Tahsildar after hearing the petitioner and advertent to the title deed claimed by the petitioner within a period of one month from the date of receipt of a copy of this judgment. Depend upon the outcome of such decision, basic tax can be accepted.
