Heard the learned counsel for the petitioner and the learned State Attorney. No notice is being issued to respondents 6 and 7 in view of the judgment which is being passed.

2. Petitioner has prayed for a direction to respondents 1 to 5 to afford adequate protection and sufficient police aid for operating the petitioner's stage carriage vehicle bearing Regn.No.KL-04-Q-7934. Petitioner's case is that obstruction has been made by the private respondents in running of the vehicle with regard to which he has already filed a compliant, the copy of which has been annexed as Ext.P5 dated 16/11/2015.
