Ashok Bhushan, C.J.

Heard the learned Government Pleader. No notice is being issued to respondents 6 to 9 in view of the judgment which is being passed.

2. Petitioner has filed this writ petition seeking for police protection. Petitioner's case is that he had deposited money in Fixed Deposit and withdrawal of which turned into some dispute, which resulted in litigation. The allegation is that party respondents are keeping enmity with the petitioner.

3. Learned Government Pleader after obtaining instructions submits that petitioner had taken a loan against Fixed Deposit. Hence, there was some dispute regarding the encashment of the Fixed Deposit. It is stated that respondents are bank officers and there are no such incidents on the basis of which any police protection can be provided to the petitioner.
