JUDGMENT

The petitioner, who is faced with a demand notice under the Kerala Revenue Recovery Act, for recovery of amounts confirmed against him by a final determination order passed under the Kerala Toddy Workers Welfare Fund Act, 1969, seeks only some time to pursue his appellate remedy against the final determination order.

2. I have heard the learned counsel for the petitioner, the learned Government Pleader for respondents 1 and 2 as also the learned Standing counsel for the 3rd respondent.

On a consideration of the facts and circumstances of the case as also the submissions made across the bar, I direct that recovery steps pursuant to Ext.P1 notice as against the petitioner shall be kept in abeyance for a period of ten days from the date of receipt of a copy of this judgment, so as to enable the petitioner to work out his appellate remedy, against the final determination

order, under the Kerala Toddy Workers Welfare Fund Act.

The writ petition is disposed as above.
