J U D G M E N T

The validity of temporary permit issued in favour of the second respondent expires on 30.11.2015. It is reported that the second respondent has applied for re-issue of temporary permit.

2. I direct the first respondent to conduct a timing conference well ahead of 30.11.2015 in the circumstances. This is in view of Ext.P4 objection filed by the petitioner as regards the allotment of time schedule to the second respondent. The re-issue of temporary permit in favour of the second respondent shall be preceded by a timing conference by the first respondent. The right of the second respondent to have a re-issue of the temporary permit is not in any way impaired.

The writ Petition is disposed of.
