It is the case of the petitioner that the regular permit holder is not operating the route Karuvanthiruthikadave - Feroke - Ramanattukara - Perumugham - Pullikadave. The petitioner is the owner of a tax paid idle vehicle bearing registration number KL-10-L-6462. The petitioner filed Ext.P1 application, for the grant of temporary permit for the above vehicle bearing registration number KL-10-L-6462 in the place of KL-11-Z-2277, till the route bus resume service. According to the petitioner, the said route passes through the ill served rural areas and the granting of temporary permit to him is beneficial to the interest of travelling passengers also. Hence, the petitioner seeks a

direction to the respondent to consider and pass orders on Ext.P1.

2. Heard the learned counsel for the petitioner and the learned Government Pleader.
