**JUDGMENT**

The petitioner applied for renewal of gun licence. This was rejected as per Ext.P3. Against rejection, the petitioner approached the Land Revenue Commissioner. The Land Revenue Commissioner remanded the matter back to the District Magistrate, Wayanad as per Ext.P9.

2. Now, the matter is pending before the District Magistrate, Wayanad for free enquiry and decision.

3. In the light of facts and circumstances, there shall be a direction to the 2nd respondent to consider and pass orders based on the remand order produced on Ext.P9 within a period of one month, necessarily, while taking

decision, the judgment of this Court produced as per Exts.P7 and P8 shall be adverted.
