JUDGMENT

The petitioner is the owner in possession of 10 cents of property in Sy No.82/2 of Kattiparuthy Village of Tirur Taluk in Malappuram district. According to the petitioner, the said land at present is a dry land, which was reclaimed long years back and the said property is not included in the data bank as paddy field. So he filed Ext.P5 application seeking building permit to construct a residential building. The grievance of the petitioner is that Ext.P5 has not been considered so far, despite a long lapse of time.

2. Having regard to the grievance projected in this writ petition, the respondents are directed to consider and pass orders on Ext.P5, within a period of one month from the date of receipt of a copy of this judgment.
