J U D G M E N T

The petitioner is the holder of an Explosive License, which was expired on 31.03.2015, as seen from Ext.P3. The petitioner has submitted Ext.P2 application before the 2nd respondent for renewal of the said license. The application was pending since 24.02.2015.

In that view of the matter, there shall be a direction to the 2nd respondent to dispose of Ext.P2 application submitted by the petitioner, within a period of one month from the date of receipt of a copy of this judgment. Till a decision is taken on the application, no coercive steps shall be taken against the petitioner.
