JUDGMENT

The petitioner is an applicant for the grant of a regular permit on the route Pavaratty-Thrissur with respect to stage carriage bearing Registration No.KL-46/C-3303. The said application for regular permit is being considered and in the meanwhile, the petitioner applied for a temporary permit by Ext.P6. The grievance of the petitioner is that Ext.P6 has not been considered so far. It is only appropriate that Ext.P6 temporary permit application be considered and orders be passed at the earliest.
