JUDGMENT

The petitioner claims that pursuant to final decree through execution proceedings thereon. She has become the absolute owner in possession of the property referred in Ext.P5 application. The petitioner submits that the Revenue Officials refused to act upon the request to effect the transfer of registry.

2. This Court is of the view that if the petitioner produces a final decree and records relating to the delivery necessarily based on the above, transfer of registry shall be effected without any delay, at any rate, within one month of production of such document.
