JUDGMENT

Petitioner passed out Secondary School Examination (X Std) conducted by CBSE in the year 2013. The petitioner applied for correction of the name of mother and father in Ext.P1 certificate on 13.05.2015. The said application has been rejected citing that, as per the amended Bye law dated 25.06.2015 such application shall be made within one year from the date of declaration of results.

2. In respect of petitioner's Higher Secondary Certificate, the details have been correctly noted. Mistake is only in respect of the Secondary School Certificate. In fact, the school authorities have corrected records. Further, amended Bye law would relate to applications only after 25.06.2015. In that view of the matter, the impugned order is set aside. There shall be a direction to the 1st respondent to correct the Certificate issued to the petitioner, produced as Ext.P1 in tune with the school records. The school authority shall forward the corrected school

records within two weeks. Thereafter, CBSE shall carry out the correction in the Secondary School Certificate within three months.

Writ petition is disposed of.
