Heard learned counsel for the petitioner and learned Government Pleader.

2. This writ petition has been filed seeking police protection. Petitioner's case is that he has been threatened by respondents 2 and 3, who are sons of the brother of the husband of the petitioner. Petitioner claims to have filed Ext.P1 complaint.

3. A perusal of Ext.P1 indicates that no specific incident has been mentioned which can be enquired by the police. We see no reason to issue any direction. We however observe that it shall be open for the petitioner to file a complaint if any offence is committed or attempted to commit offence.

The Writ Petition is closed with the above observation.
