JUDGMENT

The petitioners if aggrieved by Ext. P11 order can maintain a revision under Section 90 of the Motor Vehicles Act, 1988. This is particularly so since Ext.P5 revision petition filed by the first petitioner in regard to the settlement of timings earlier is pending consideration with the State Transport Appellate Tribunal.

2. The petitioners are free to apply for appropriate interim orders in the revision petition if any filed against Ext. P11 order. Any such revision petition shall be heard along with Ext. P5 revision petition within a period of two months from its preferment.

The writ petition is disposed of.
