JUDGMENT

Ext. P6 appeal numbered as ATA No. 1227/2015 filed against Ext. P5 order is pending disposal. The Employees Provident Fund Appellate Tribunal is yet to commence sitting at Bangalore. Ext. P6 appeal is accompanied by a prayer for stay of coercive steps.

2. It is only proper that coercive steps pursuant to Ext. P5 order are put on hold in the meanwhile. Ext. P6 appeal shall be forwarded to the appropriate bench as soon as the sitting commences.
