Ashok Bhushan, CJ.

Heard the learned counsel for the petitioner and the learned Government Pleader.

2. The petitioner has come up with this writ petition seeking for police protection. It is submitted that the petitioner is working as 'Mel Saanthi' in a temple, in which, the 5th respondent is creating obstruction in performing poojas etc. A complaint is also stated to have been filed by the petitioner, Ext.P5.

3. Learned Government Pleader on instructions would submit that the 5th respondent, N.S.S. Karayogam represented by its Secretary, has nominated a person, one Suresh as 'Mel Saanthi' and there is dispute regarding entitlement of 'Mel Saanthi'.

4. We are of the view that the issues raised in this writ petition cannot be adjudicated in a police protection matter. It shall be open for the petitioner to take such steps to obtain
