JUDGMENT

Petitioner's vehicle bearing Registration No. KL-18-A-5987 is ordered to be confiscated under the provisions of Protection of Kerala River Banks and Regulation of Removal of Sand Act. The vehicle was released to the petitioner on interim custody on deposit of Rs.1,00,000/-. Now the petitioner has been directed to surrender the vehicle or to pay the balance amount of Rs.1,90,000/-. Ext.P5 is the notice.

2. Considering the facts and circumstances, the petitioner is permitted to pay the balance amount in 20 equal monthly instalments, starting from 16.01.2015. If the petitioner commits any default, the respondent will be at liberty to proceed further in accordance with law.

The writ petition is disposed as above.
