JUDGMENT

The petitioner is a Devaswom. They allege that Devaswom properties have been encroached. They approached the District Collector by Ext.P4 to take immediate action to remove the encroachment.

This Court is of the view that necessary action shall be taken on petitioner's complaint by the District Collector, Kannur within two months and if it is found that there are encroachments, necessary action shall be taken under the Kerala Land Conservancy Act to remove the encroachments.
