The petitioners have filed this writ petition seeking for police protection. It is alleged that respondents 4 to 6 have trespassed into their property and forcing them to part with the money. It is admitted by the petitioners that they had financial transaction with the private respondents. Ext.P4 is the complaint filed by the petitioners before the police. It is stated that despite receipt of Ext.P4, no action has been taken by the police.
