**JUDGMENT**

C.K. Abdul Rehim, J

Pursuant to the order passed by this court on 21.05.2015, the respondents 6 and 7, who are parents of the alleged detainee, Miss.Soumya, had produced her before this court. We have interacted with the alleged detainee Miss.Soumya. She stated on categorical terms that she is living with respondents 6 to 8 at her parental house in her own will and that she had not taken any decision to marry the petitioner. She expressed her desire to go back along with the parents.

2. Under the above mentioned circumstances, we are convinced that the alleged detainee Miss.Soumya is not under any illegal confinement of respondents 6 to 8, as alleged in this writ petition. Hence the writ petition

deserves no merit and interference of this court and is not at all warranted to release of the alleged detenue.

Therefore the writ petition is hereby dismissed.
